**Day 1: USA - Amsterdam**

General Montgomery hoped to capture the Rhine Bridge in Arnhem to reach Berlin and finish the war by Christmas 1944. Later return to your luxurious ship and spend the remainder of the day cruising through Holland into Belgium.

**Meals: (B, L, D) Overnight: Amalegro/Amacello**

**Day 5: Antwerp**

This morning enjoy a guided sightseeing tour of **Antwerp**, the second-largest Belgian city and one of the world's most important ancient seaports. Visit the **Grote Market** with its beautiful city hall and Church of our Lady, and admire the city's superb architecture. The afternoon is free to explore **Antwerp** on your own or take an optional excursion to nearby Brussels, Belgium's capital and a city of striking contrasts with a proud medieval past. After dinner your cruise departs for Ghent.

**Day 6: Ghent**

Disembark after breakfast for a guided sightseeing tour of **Ghent**, the fourth largest city of Belgium. The city is the real diamond of Flanders. In a unique way Ghent has managed to preserve its medieval power while keeping up with the times. The city center alone is a showcase of medieval Flemish wealth and commercial success. The afternoon is free to explore more of Ghent or to take an optional excursion to fascinating Bruges, one of Europe's most perfectly preserved medieval cities.

**Day 7: Willemstad - Dordrecht**

This morning sail through the Dutch region of **Zeeland**, where you'll find one of the world's most complex engineering projects, the **Delta Works**, which took over 30 years to complete. Stop in charming **Willemstad** for a walking tour. Return to the ship to enjoy a scenic lunch as you sail towards **Dordrecht** and the 18th-century windmills of **Kinderdijk**. Kinderdijk is the largest group of original windmills in Holland.

This morning cruise from **Dordrecht** along the Amsterdam-Rhine Canal to **Utrecht**. Keukenhof also offers several lakes, sculpture gardens, greenhouses, a windmill open for inspection and several terraces to relax. The rest of the day is at your leisure.
